This is a reading list about Manila, the Philippines. As with Manila, it sprawls, in dendritic and uneven ways, reflecting the interests of its authors.

It considers work in/on urban, urbanizing, and in-transition lowland Luzon, the ribbon of *desakota* stretching from Lingayen to Lucena.

It also considers processes that are key to understanding Manila in the early 21st century: disasters, exclusion, outsourcing, remittances, global production and reproduction networks, urbanism and urbanization elsewhere in the Philippines, Southeast Asia, the Global South.

It will neither assume nor impose a clearly-defined boundary to Manila. Nor will it attempt to be the authoritative bibliography about Manila.
